Important Information for Members and Members looking to become a Director of QYAC

Directors Training

Members seeking to nominate as a director at this AGM must attend a QYAC Directors Training session being offered at Minjerribah Ganaba at **2:00pm on Friday 2 December 2022**.

Please note that this training is specific to QYAC and completion of this course is a prerequisite to nomination to become a director.

If you intend to undertake this training, please contact admin@qyac.net by 25 November 2022.

The session runs for approximately 2 hours and ensures that nominees understand the roles and responsibilities of being a director under the *Corporations (Aboriginal and Torres Strait Islander) Act 2006* (Cth) and QYAC Rulebook.

Proxies - QYAC 2022 AGM

A member who is entitled to attend and cast a vote at a general meeting may appoint a person as proxy to attend and vote for them at the meeting. The person appointed as a member's proxy must be a member of QYAC. The appointment can only specify one proxy vote per member. A proxy's authority to speak and vote for a member at a meeting is suspended if the member is present at the meeting.

To appoint a proxy, please complete the attached Proxy Vote Form and mail or deliver it to QYAC so that it is received at QYAC's office at least 48 hours before the meeting, that is, by 9:00 am on Thursday 1 December 2022.

In accordance with the QYAC Rule Book, any proxies received after that date/time including proxies received on the day will be invalid. **A Proxy Vote Form is attached to this Notice.**

Voting - QYAC 2022 AGM

All matters, except the election of directors, are to be decided by vote of the members present at the meeting and valid proxy votes, by simple majority.

There is one director's position for each of the 12 Quandamooka Families. The directors' positions for each family will be appointed for 3 year terms. Where a director steps down before the end of the 3 year term, a family will elect the director for the remainder of that term at the following AGM.

Upon registration, each member will be provided with a coloured wristband to vote. Election for family group directors will be conducted with only those wearing an appropriate coloured wrist band being allowed to vote.

When a director's term expires or a director resigns, nominations for the family director position will be called. If there is only one nominee for director in respect of the 12 director's positions then the nominee will be appointed unopposed. If there is more than one nominee for family director then the appointment is determined by vote of those members present at the meeting who are also members of the relevant Quandamooka Family.

In accordance with the CATSI Act, where elections for Directors to the QYAC Board are held, all nominating members will be required to complete a **Consent to Become a Director Form** to enable the member to stand in the election.

Members are asked to please provide details of any changes to ensure our membership register can be kept up to date.

As outlined in QYAC rules, there is no financial assistance provided to attend the AGM. The QYAC 2021-2022 Annual Report can be accessed on our website www.qyac.net.au
